ORDER CHANGES/CANCELLATIONS

- Most orders ship within 48 hours of your order.
 Call us immediately to inquire about the possibility of making changes/ cancellations.
 Changes/cancellations must be confirmed IN WRITING. Cancellations may not be made after an order ships.
- Upholstered chairs and sofas will incur a 10% cancellation fee if production has started.

CREDIT POLICY

- Affordable Display Products will extend credit to approved customers with current accounts.
- New customers must submit signed credit application including bank and trade references with current fax numbers.
- Upon credit approval, initial order will ship, subject to approved credit limits.
- Subsequent orders will be shipped on open credit, subject to approved credit limits and current account status.
